

RULES OF USE

for the barbecue area Scheiblerplatz

Please:

- only use the barbecue and fire sites provided. The setting up of additional barbecue and fire sites is not permitted!
- Be considerate of the neighbourhood: avoid noise and unnecessary smoke (grill only with charcoal, not with wood)!
- leave the site as you would like to find it:
 - take your rubbish back with you!
 - clean the tables and barbecue after use and dispose of ashes and charcoal residues in the ash bin provided!
- follow these few rules so that many people can enjoy this barbecue area for a long time!

Attention:

- The barbecue area may only be used between 8.00 am and 10.00 pm.
- Use of the barbecue area is at your own risk.
- The barbecue and fireplace must be supervised at all times.
- Suitable material for extinguishing a fire must be provided (sand, fire extinguisher, fire blanket).
- Do not extinguish the barbecue with water, as there is a risk of scalding from the steam produced!
- Camping is prohibited.
